Citywide Drainage Project

This project provides drainage and paving improvements that will benefit the City of Southside Place. The drainage improvements to the areas of Edloe Avenue, Auden Street, and Harper Street will help move water from the area more effectively and will reduce the impact of the regional drainage area. The proposed improvements will increase the drainage capacity to convey a 2-year event. This drainage system outfalls into Poor Farm Ditch (HCFCD Unit D111-00-000) and includes mitigation for impacts to Poor Farm Ditch.

This project will be partially federally funded by the U.S. Housing and Urban Development (HUD) Department through the Texas General Land Office (GLO) and administered by the Harris County Community Services Department (HCCSD). Bidders shall comply with regulations governing the CDBG Disaster Recovery Program (Regulation 24 CFR 570). Applicable requirements include but are not limited to compliance with the Davis-Bacon and Related Acts, Fair Labor Standards, Equal Employment Opportunity, Affirmative Action, Section 3 of the HUD Act of 1968, and contracting with small, minority, and disadvantage firms, as detailed in the project manual.

Bidders will be required to furnish verifiable references with their bids/proposals and to have a payment and performance bond.
